- B. Motion to consider approval of a resolution related to the provision of a loan(s) to support a project (or projects) in Kanawha, and/or Jefferson, and/or Monongalia Counties, West Virginia.

A motion was made by Mr. Hartley to approve the Governor's request for a \$54,000,000 forgivable performance loan to Zenith Electronics LLC creating a minimum of 275 jobs. The motion was seconded by Mr. Ritchie and unanimously carried.

WHEREAS, the board determined that the public purpose of the West Virginia Economic Development Authority Act would be met by a forgivable performance loan in the amount of \$54,000,000 to Zenith Electronics LLC.

NOW, THEREFORE, BE IT RESOLVED: That the forgivable performance loan request to Zenith Electronics LLC in the amount of \$54,000,000 is given preliminary and final approval.
