# 2. Mineral County Development Authority Corp. – Loan Application

NOW, THEREFORE, BE IT RESOLVED: That the loan request to Mineral County Development Authority Corp in the amount of \$720,000 is given preliminary and final approval.

## 3. Putnam County Development Authority, Incorporated – Loan Application

A motion was made by Mr. Irby to approve a 15-year term loan to the Putnam County Development Authority, Incorporated in the amount of \$1,575,000. The motion was seconded by Mr. Canterbury and unanimously carried.

WHEREAS the board determined that the public purpose of the West Virginia Economic Development Authority Act would be met by a loan in the amount of \$1,575,000 to Putnam County Development Authority, Incorporated.

NOW, THEREFORE, BE IT RESOLVED: That the loan request to Putnam County Development Authority, Incorporated in the amount of \$1,575,000 is given preliminary approval.
