NEW BUSINESS

A. Extension of \$32,074,350 Tax Exempt Industrial Development Bonds on behalf of Nucor Steel West Virginia LLC project in Mason County, West Virginia

Ms. Batten presented a request by Nucor Steel West Virginia LLC for an extension of \$32,074,350 Tax Exempt Industrial Development Volume CAP reservation for its project in Mason County, West Virginia. The reservation was originally approved on January 16, 2025. This extension is for an additional 120 days with the expiration of October 16, 2025.

A motion was made by Mr. Irby to approve the extension of WVEDA's Tax-Exempt Industrial Development Volume CAP reservation to Nucor Steel West Virginia LLC in the amount of \$32,074,350 until October 16, 2025. The motion was seconded by Mr. Hartley and unanimously carried.

B. Proposals for Legal Contracts for the 2025-2026 Fiscal Year

- Mr. Webb presented an Engagement Letter from Spilman Thomas & Battle PLLC for fiscal year 2025-2026 to provide legal services as general counsel to the West Virginia Economic Development Authority (WVEDA). The WVEDA Governing Statute W. Va. Code 31-15-6(39) states that the WVEDA may enter legal contracts and hire outside counsel.
- 2. Mr. Webb presented an Engagement Letter from Bowles Rice, LLC for fiscal year 2025-2026 to provide legal services as co-counsel to the WVEDA. The WVEDA Governing Statute W. Va. Code 31-15-6(39) states that the WVEDA may enter legal contracts and hire outside counsel.

Tema North America , LLC Equipment Loan Application

A motion was made by Mr. Irby to approve a 10-year loan to Tema North America, LLC in the amount of \$2,000,000. The motion was seconded by Mr. Lorenze and unanimously carried.

WHEREAS, the board determined that the public purpose of the West Virginia Economic Development Authority Act would be met by a loan in the amount of \$2,000,000 to Tema North America, LLC.

NOW, THEREFORE, BE IT RESOLVED: That the loan request to Tema North America, LLC in the amount of \$2,000,000 is given preliminary and final approval.

A. Resolution authorizing the West Virginia Economic Development Authority to approve change orders with regard to its contract with SafeCo Environmental, Inc. for the demolition, removal, remediation, and disposal of structures, fixtures, equipment, debris, waste and other materials at the former Century Aluminum Plant site located near Millwood in Jackson County, West Virginia, now owned by the West Virginia Economic Development Authority.

Mr. Brouse presented the resolution authorizing the West Virginia Economic Development Authority to approve change orders with regard to its contract with SafeCo Environmental, Inc. for the demolition, removal, remediation, and disposal of structures, fixtures, equipment, debris, waste and other materials at the former Century Aluminum Plant site located near Millwood in Jackson County, West Virginia, now owned by the West Virginia Economic Development Authority. The resolution authorizes the Authority to enter into an

amendment to the Demolition Contract that extends the term until March 31, 2029, in order to complete all of the work at the Project.
